- **Private Pool** parties may be reserved from 8:30 p.m. to 10:30 p.m. and Monday from 11 a.m. to 1 p.m., providing no other special event is scheduled. It is advised that NO ALCOHOL is served on pool premises. Person listed on this application takes full responsibility for the behavior, safety and liability of every guest.
  - o \$150 per Party up to 25 people
  - o \$200 per Party 26 - 50 people
  - o Includes:
    - \$50 Rental Fee for a 2-hour party (payment required with reservation form)
    - Lifeguard Fee \$50 per lifeguard (1-25 guests require 2 Guards, 26 - 50 requires 3 Guards)
  - o 50+ people negotiable with Pool Board
  
- **Courtyard Pool Parties** parties held during normal operation hours are available to FC members ONLY. They must end on or before 6 pm on any day. Party guests of members and non-member swimmers are permitted. All non-member swimmers, are limited to 10. Private party rates do not apply. Reservation is required. Non-swimmers are no charge. The courtyard is located on the north side of the pool behind the girl's bathroom. It is a two hour limit for the courtyard.  
**\*\*\*\*\*Absolutely no parties may be held in the pool patio areas. It must be booked in the courtyard or held in the park. The park is on a first come basis\*\*\*\*\***
  - \$25 usage fee applied plus a \$5 guest pass fee must be purchased for all non-members up to 10. \$75 maximum total (\$25 usage + a maximum of 10 guests at \$5)

### AGREEMENT:

The applicant/sponsor by their signature affixed below agrees to the following:

- Applicant will be responsible for any damages to the premises caused by the Applicant and/or guests. Damage is destruction of any part of the facility or its fixtures, interior or exterior. Applicant agrees to leave the premises in a good and clean condition, removing all trash to the dumpster area to the rear of the recreation center parking lot. The lifeguards on duty are responsible for locking up the facility after the function. The function will under no circumstances continue past 10:30 p.m. Applicant will begin clearing the pool and bathhouses at 10:15 p.m. in advance.
- Cancellation Policy: If pool is closed due to inclement weather, party will be rescheduled. No refunds given.
- Applicant has read and agrees to comply with all swimming pool rules and regulations, attached hereto as an addendum to the contract. Any infraction of these rules or the addendum to the contract that cause damages to the facility will be charged to the name on this applicant, as determined by the FCR Board.

- Applicant hereby waives any right, claim, or cause of action, whether based on allegations of negligence or otherwise, against Forest Creek Recreation, Inc., their assigns or their respective officers, committee volunteers, employees, or agents, and release them from any and all liability for any personal or property injury, cost, damages, expense, or claim which applicant or anyone on their behalf might have as a direct or indirect result of Applicant's participation at the Forest Creek Recreation complex.
